# Membership Terms and Conditions for the Lucidity Network

# ("Terms")

# 1. What is the Lucidity Network

The Lucidity Network is a resource for its members to provide them with tools and confidence to think differently to achieve better results, as well as to interact with each other; and is provided by Lucidity Innovation Ltd, a company registered in England and Wales with company number 08306104 ("We", "Us" or "Our").

These Terms will govern Our relationship with members of the Lucidity Network ("members" or "you"/"your"). By becoming a member, you agree to comply by these Terms.

If you do not comply with these Terms and Our website terms and conditions, We reserve the right to suspend or terminate your membership and possibly take legal action if deemed necessary by Us.

#### 2. How to Become a Member

Anyone over the age of 18 can become a member by emailing hello@lucidity.org.uk and completing the sign up form and agreeing to pay the subscription fees set out below.

#### 3. Subscription Term and Fees

Members can choose to either pay (i) monthly or (ii) annually at a discounted rate.

The current subscription fees are: Monthly £19.97 Annually £219.00

Membership can only commence once you have paid your first instalment of subscription fees. You will be advised by email of your exact membership start date.

Monthly membership subscribers can terminate their membership at any time by giving Us at least 2 weeks written notice, subject to a minimum subscription term of 4 weeks.



Annual membership subscribers can terminate at any time by giving Us at least 2 weeks written notice, ending on a date that is the anniversary of their membership start date.

All members are entitled to a cooling off period of 2 weeks from the date they become a member whereby they can cancel their membership by giving notice to <u>hello@lucidity.org.uk</u>, and receiving a full refund of any subscription fees paid in respect of goods and services not already provided at the date of termination. Other than the foregoing and pursuant to paragraph 7, there shall be no refunds of subscription fees.

Non payment of fees will result in your membership being terminated.

## 4. Membership Benefits

We will provide all members with the following on a monthly basis:

- a 'Lucidity Kit' being a themed downloadable guide;
- a webinar on the monthly theme; and
- a Q&A through Facebook live.

In addition, members shall have access to the Lucidity Network Facebook Community group.

We also host 4 networking events each year. All then current members at the time of a networking event are welcome to attend such event free of charge.

There is also a reduced price on coaching for members of 4 months or more – (Any coaching services provided by Us are subject to their own terms and conditions which will be made available to the member at such time).

#### 5. Membership Rules

We reserve the right to suspend or terminate your membership if you do not abide by the below rules. They apply to all content that you contribute to the online Lucidity Network Community and to all interactive services We provide you. You must follow these standards carefully, but please also follow the spirit of them.

Your contributions must be:

- accurate (if they are factual);
- genuine (if they state opinions);
- within the law.

Your contributions must not be:

• defamatory, obscene or offensive



likely to deceive, harass, annoy, threaten, or invade someone else's privacy

Your contributions must not:

- promote material that is sexually explicit;
- promote violence, or discrimination based on race, sex, religion, nationality, age, disability, or sexual orientation;
- infringe anyone else's intellectual property;
- be used to impersonate anyone, or misrepresent anyone's identity;
- be used for your own advertising or promotional purposes;
- encourage or assist anything that breaks the law.

## 6. Intellectual Property

All intellectual property which exists in the materials provided to members as part of their subscription are owned by Us.

Membership does not confer any right to use Our intellectual property, including Our brand and logo, except where expressly provided in writing.

#### A member shall not:

a. licence, sell, rent, lease, transfer, assign or otherwise commercially exploit materials provided as part of the subscription, including passwords, provided to the member by Us; or

b. licence, sell, rent, lease, transfer, assign or otherwise commercially exploit or otherwise make any of Our services available to any third party.

#### 7. Guarantee

Subject to you having correctly followed all the advice, guidance and instructions provided as part of your membership benefits (as determined by Us, acting reasonably), if you have not achieved the tangible goals set out at the start of your membership (as determined by Us, acting reasonably) within 6 months from the start of your continuous membership, We will refund you any subscription fees paid.

#### 8. Liability Limitation

Except for the refund rights set out in these Terms or unless prohibited by law, our maximum liability to you for any breach of these Terms by Us is £25.

#### 9. Force Majeure

In the event of a force majeure event, We shall not be deemed to be in breach of these Terms and in particular shall not be liable for a delay or for non-



performance of any of Our obligations under these Terms or for any loss or damage occasioned thereby. To the maximum extent permitted by law, all losses arising for this reason shall not be recoverable by a member.

# 10. Variation

At Our absolute discretion, We may at any time alter, amend, change, modify or withdraw any of the membership benefits that comprise the membership offering. It will be your responsibility to keep up-to date with all such changes and your membership renewal and continued use of the member services shall be deemed acceptance of any changes to these Terms.
